Event Participation

Trail running is a physically demanding sport that involves risks of injury, illness, or property damage.

Participants must ensure they are medically fit and adequately prepared before entering an event. By entering, you confirm that you have no medical conditions that would make participation unsafe. Participants under 18 years of age must have written consent from a parent or guardian.

Safety

True Grit Trails provides medical support, trained sweepers, and route management; however, these do not remove all risks associated with trail running.

Participants must obey all safety instructions from event marshals and organisers.

Any participant found to be acting recklessly may be disqualified or removed from the event.

Registration & Payment

Entries are processed through our official online platform.

Entries are only confirmed once full payment has been received.

Entries may be transferred to another participant or deferred to a future event only if approved by True Grit Trails and within the specified timeframe before race day.

Event Changes or Cancellations

True Grit Trails reserves the right to cancel, postpone, or modify any event due to weather conditions, safety concerns, venue issues, or circumstances beyond our control.

If an event is cancelled due to force majeure (e.g. fire, floods, pandemics, government restrictions), no refunds will be issued, but entries may be deferred or credited to a future event.

By entering, you agree that True Grit Trails (Pty) Ltd, its directors, employees, contractors, sponsors, and partners are not liable for any injury, loss, or damage to person or property arising before, during, or after any event, except where required by law.
